Fifteenth Stated Meeting of the Lowcountry Presbytery July 27, 2019

The Fifteenth Stated Meeting of the Lowcountry was held at 9:00 a.m., July 27, 2019 at Church Creek Presbyterian Church, Charleston, SC.

Worship
Service 9am

Worship service began at 9:00am. Rev. John Olsen led the Call to Worship from Psalm 111. After the congregation sang *Holy, Holy, Holy* Rev. Olsen gave the Prayer of Invocation. Rev. Walters read Exodus 34:5-8 and led the Confession of Sin and gave the Assurance of Pardon from Ephesians 2:4-7 and 1 Corinthians 1:31. The congregation sang, *Before the Throne of God Above*. Rev. Rob Hamby read Psalm 67 and then preached a sermon entitled, *Blessed to Be a Blessing*. After singing *All Hail the Power of Jesus' Name* the congregation confessed their faith by reciting *The Apostle's Creed*. Rev. Donovan properly fenced the table and led in the celebration of The Lord's Table. The congregation sang, *O Great God*. A benediction was pronounced.

Call to Order

The Fifteenth Stated Meeting of the Lowcountry Presbytery was called to order by the moderator, TE Michel Walters 10:20am in the fellowship hall of Church Creek Presbyterian Church, Charleston, SC. TE David Donovan, opened the meeting with prayer.

Roll Call & Quorum

TE Michael Walters asked the Stated Clerk if there was a quorum. The Stated Clerk declared that a quorum was present.

Docket Approval

M/S/C: that the modified docket for the 15th Stated meeting of Lowcountry presbytery submitted by the Administration Committee and posted on the website and electronically distributed to presbyters be approved as modified.

M/S/C to approve the of 14th Lowcountry Presbytery minutes for April 23, 2019 as presented.

Appointment of Committee of Thanks

M/S/C: The Moderator appointed TE JP Sibley and TE Bill Harritt to the Committee of Thanks.

Introduction of Guests

Guests & first-time commissioners were introduced.

Ministry Equipping Time

RE Arklie Hooten, TE Curt Moore: *Ministry Opportunities in Disaster Response* They took time to explain and describe the PCA MNA Disaster Relief ministries.

RE David Walters, Jr. prayed for RE Arklie Hooten and TE Curt Moore to close the

ministry equipping time.

Business & Reports:

At 11:30am, TE Michael Walters, the moderator called the presbyters back to order to begin the business of the day.

M/S/C: RE Rich Wylly made the following motion: Motion: In light of today's Ministry Equipping Time that the MNA Committee be tasked with developing a Disaster Relief Plan. In addition, that each of our individual churches are also

encouraged to do an assessment of their capabilities and provide the name of a point person to the MNA Committee. That the MNA report back to the 16th Stated meeting of the Lowcountry Presbytery.

Shepherding Committee

TE Ron Steel introduced Tami Driggers, a member of Metro North PCA, who addressed the presbytery regarding the effective ministry of TE Howard Cole. TE Ron Steel led in prayer for the Driggers family, TE Howard Cole and Metro North PCA.

MNA & MTW Committee

RE Rich Wylly gave the report.

Discussion and motions regarding the call of Church Planters to the Lowcountry Presbytery: TE Rob Hamby and TE Nathan Francis.

RE Rich Wylly introduced TE Nathan Francis who is considering planting in the Cane Bay area and TE Rob Hamby who is considering planting in the Cainhoy Peninsula.

M/s/c: that the presbytery extend a call to TE Rob Hamby and TE Nathan Francis to be church planters within the Lowcountry Presbytery. The Shepherding Committee has reviewed their call packages and determined they are sufficient and in good order.

Order of the Day: Lunch

TE Donovan gave instructions regarding lunch & led in prayer.

TE J.P. Sibley presented a Resolution of Thanks from the Committee of Thanks: Whereas, the 2019 Summer meeting of Lowcountry Presbytery met at Church Creek Presbyterian Church in Charleston, SC, and;

Whereas, we were exhorted by Rev. Rob Hamby from Psalm 67 to enjoy our gospel

corndog, but we should never keep it to ourselves, and;

Whereas, we anticipate sending out two new church planters into the field of harvest, and;

Whereas, we give thanks to God for the work the PCA is doing to respond to disasters around the country and provide relief with words of hope and actions of service, and;

Whereas, the food provided by the servants of Church Creek was in no way a disaster and provided timely relief to our hearts, bodies, and souls;

Therefore, be it resolved that Lowcountry Presbytery offers its praise to our Lord Jesus Christ for his faithfulness to his church.

And we give thanks to the servants here at Church Creek who have been blessed to be a blessing.

Submitted by the Committee of Thanks for the 15th Stated meeting of the Lowcountry Presbytery and affirmed by the Lowcountry Presbytery.

BUSINESS

TE Michael Walters called the presbyters back to order at 1:03pm after the season of prayer to conduct the business of the presbytery.

Candidates and Credentials

Since TE Mark is serving combat duty with middle schoolers at Ridgehaven, **TE Chris Bowen** will lead the examinations on the floor. He opened in prayer.

Under Care Examinations: (BCO 18-2 examined by the Presbytery on experiential religion and on motives for seeking the ministry.)

David Seitzinger (Grace Coastal Church) and **Jared Murrell** (Church Creek) seek to come under care of Lowcountry Presbytery

- Both have been members for at least six months and have letters of endorsement from session.
- David Seitzinger will also begin his internship at Grace Coastal.

The committee recommends that Lowcountry Presbytery receive them both under care.

TE Chris Bowen led the examination of **Mr. David Seitzinger** in Christian Experience and Sense of Call.

TE Chris Bowen led the examination of **Mr. Jared Murrell** in Christian Experience and Sense of Call.

M/S/C: to arrest the examinations of **David Seitzinger and Jared Murrell** in Christian Experience and Call to Ministry.

M/S/C: that in accordance with BCO 18-3 the examinations of David Seitzinger and Jared Murrell who have completed the requirements of BCO 18-2 be sustained and that David Seitzinger and Jared Murrell be added to the Lowcountry Presbytery's roll of Candidates for the Ministry.

The Moderator posed the questions of BCO18-3 to the candidates:

- 1. Do you promise in reliance upon the grace of God to maintain a becoming Christian character, and to be diligent and faithful in making full preparation for the sacred ministry?
- 2. Do you promise to submit yourself to the proper supervision of the Presbytery in matters that concern your preparation for the ministry?

David Seitzinger and Jared Murrell answered in the affirmative:

TE Howard Cole gave a charge to the candidates from Ezekiel 34 and then led in prayer for their future ministry.

Transfer of Ordination: (BCO 13-6) examined on Christian experience and also touching their views in theology, the Sacraments, and church government. Any declared differences with the Westminster Standards. Assent to BCO ordination questions.)

The Rev's Nathan Francis (MNA), Rob Hamby (MNA), and Thom Watson (laboring without call, serving as interim supply at Two Rivers Church) all seek to come to Lowcountry Presbytery by transfer:

- Nathan is transferring from Western Carolina Presbytery
- Rob is transferring from North Texas Presbytery
- Thom is transferring from Western Carolina Presbytery

TE Nathan Francis shared his testimony and Christian Experience.

Nathan Francis:

Images of Jesus (2nd Commandment): I disagree with the Westminster Standards in reference to creating of images of Jesus for the purpose of education (e.g. WLC 109: ...the making any representation of God, of all or of any of the three persons, either inwardly in

our mind, or outwardly in any kind of image or likeness of any creature whatsoever). My understanding of the 2nd Commandments is that it is focused on a prohibition of creating and worshipping any and all images (i.e. both images of God and "anything that is in the heaven above or that is in the earth beneath, or that is in the water under the earth"). The Lord commanded images in the Tabernacle: cherubim, trees, and flowers; but these were not to be worshiped. I believe that images of Jesus for pedagogical purposes can be helpful to young children in Sunday School materials or storybook Bibles.

Committee's Recommendation: After considering his rationale, the committee recommends that Nathan's difference be considered more than semantic, but not out of accord with our system of doctrine.

M/S/C: that TE Nathan Francis's view concerning *Images of Jesus (2nd Commandment)* be considered "More than semantic, but not out of accord with any of the fundamentals of our system of doctrine."

Recreation on the Lord's Day (4th Commandment): I differ with the language of the Westminster Standards in reference to "recreation" on the Lord's Day (i.e. WCF XXI: ...thoughts about their worldly employments and recreations). I believe that all 10 commandments are moral law and still binding on believers today. In addition to being the fourth commandment, the sabbath is also a creation mandate (coming prior to the law and the fall). I personally do not understand my view to be an exception because I believe the 4th Commandment applies today and thus Sunday is a day for worship and rest. The only other activities permissible on the Lord's day are acts of mercy and necessity. I am opposed to all recreational activities that detract focus of the day from worship and rest. I personally think taking my family to a park for a walk or to kick a soccer ball around is a permissible activity on a Sunday afternoon and is not what the WCF is referring to as recreations.

Committee's Recommendation: After considering his rationale, the committee views Nathan's difference to the 4th Commandment as merely semantic.

M/S/C: that TE Nathan Francis' views concerning *Recreation on the Lord's Day* be considered "Merely semantic."

TE Rob Hamby shared his testimony and Christian Experience.

Rob Hamby:

Images of Jesus (2nd Commandment): This matter has never come up in North Texas Presbytery where I am a member but I recognize that all presbyteries are different and I desire to be transparent regarding my theological views and to submit myself to the will of Lowcountry Presbytery. Regarding the Westminster Standards' Position on the 2nd Commandment (WLC Question 109): I appreciate <u>The Jesus Storybook Bible</u> and have no issues related to it with regard to Westminster Larger Catechism 109.

Committee's Recommendation: After considering his rationale, the committee views Rob's difference to the 2^{nd} Commandment as more than semantic, but not out of accord with our system of doctrine.

M/S/C: that TE Rob Hamby's view concerning *Images of Jesus (2nd Commandment)* be considered "More than semantic, but not out of accord with any of the fundamentals of our system of doctrine."

Recreation on the Lord's Day (4th Commandment): I have a high view of the Sabbath/Lord's Day and firmly believe that the 4th Commandment is a creation ordinance that is binding today. Genesis 2:1-3 states that "God rested on the seventh day from all his work that he had done" and that "God blessed the seventh day and made it holy." Exodus 20:8-11 exhorts us to "Remember the Sabbath day, to keep it holy." The fourth commandment instructs us as to how to order the rhythm of our week – we are to work six days and worship and rest on the Lord's Day. I believe that the Sabbath/Lord's Day is a beautiful gift that God has given to us. The

Sabbath/Lord's Day is meant to be kept for God's glory and our good. The Sabbath/Lord's Day is a day that has been set apart for us to worship God together in public and in private. We must not forsake assembling with God's people to worship Him. I believe that Scripture highlights how the Sabbath is a day set apart for our physical, mental, and spiritual rest, refreshment, and restoration. I recognize that the Westminster Standards were written in and around a certain context in history, and I believe that that context informed the Westminster Standards' position on the Sabbath/Lord's Day. It seems to me that there could have been a greater emphasis on the Christian Sabbath as a day of rest. In my view, there seems to be a stronger emphasis on what we ought to do and there appears to be a lot of doing. I am concerned by how the Church and culture today view the Christian Sabbath as an afterthought (ie. fail to remember it) and center the day around sporting events (especially youth sports) and other recreations and thereby forsake the assembly of God's people and fail to keep the Sabbath holy. I believe we are reaping the consequences of this today. I also believe that physical, mental, and spiritual rest are important on the Sabbath. I believe that some forms of recreation are appropriate toward that end. Such forms of recreation for our family would be taking walks together, enjoying God's creation, going for a ride in God's creation, and in Charleston I'd say taking a walk on the beach and reading a book by the ocean. Committee Recommendation: After considering his rationale, the committee views Rob's difference to the 4th Commandment as merely semantic.

M/S/C: that TE Rob Hamby's views concerning Recreation on the Lord's Day be considered "Merely semantic."

TE Thom Watson shared his testimony and Christian Experience.

Thom Watson:

Images of Jesus (2nd Commandment): I do not believe that the worship of images is permitted, but I do have a Storybook Bible for teaching my children Bible stories at a level they can apprehend.

Committee Recommendation: After considering his rationale, the committee views Thom's difference to the 2nd Commandment as being more than semantic, but not out of accord with our system of doctrine.

M/S/C: that TE Thom Watson's view concerning the 2nd Commandment be considered "More than semantic, but not out of accord with any of the fundamentals of our system of doctrine."

TE Chris Bowen led the examination of Nathan Francis; Rob Hamby; and Thom **Watson** in the area of their Christian Experience.

TE Chris Bowen led the examination of Nathan Francis; Rob Hamby; and Thom Watson in the area of their Views in Theology.

TE Chris Bowen led the examination of Nathan Francis; Rob Hamby; and Thom **Watson** in the area of Sacraments.

TE Chris Bowen led the examination of Nathan Francis; Rob Hamby; and Thom **Watson** in the area of his views on Church Government.

M/S/C that examinations of Nathan Francis; Rob Hamby; and Thom Watson in their views in the areas of Christian Experience, views in Theology, views touching the Sacraments, and his views on Church Government be sustained. That the exams for transfer of ordination for Nathan Francis; Rob Hamby; and Thom Watson in their entirety be approved and that they each be entered on the rolls of Lowcountry Presbytery. Motion Adopted.

M/S/C that Nathan Francis; Rob Hamby; and Thom Watson be received into membership in the Lowcountry Presbytery, being received from their respective presbyteries, pending official notification of their release from that Presbytery. Motion adopted.

TE Chris Bowen welcomed **Nathan Francis; Rob Hamby; and Thom Watson** as Teaching Elders of the Lowcountry Presbytery and extended the right hand of fellowship to him, after which he was asked to sign the ministerial obligation form per BCO 13-7.

TE John Olson led the presbytery in prayer for **Nathan Francis**; **Rob Hamby**; **and Thom Watson** and his ministry in the Lowcountry Presbytery. This closed the report of the Candidates and Credential Committee.

RE Nate Arnold was appointed by the moderator to review the minutes of Two Rivers PCA.

M/S/C: that commissioners TE Howard Cole, Rich Wylly, John Schley, David Walters, Jr. be appointed to install TE Nathan Francis and TE Rob Hamby at the worship service of the 17th Stated Meeting of the Lowcountry Presbytery in January 2020.

Motion & 2nd: TE JP Sibley moved: Motion that we form an ad hoc committee appointed by the moderator for the purpose of encouraging the churches of our presbytery as we pursue racial reconciliation.

Amendment & 2nd: that there be a minimum of 2 ruling elders appointed to that committee. Motion carries.

M/s/c: that the Lowcountry Presbytery form an ad hoc committee with a minimum of two (2) ruling elders, appointed by the moderator for the purpose of encouraging the churches of our presbytery as we pursue racial reconciliation.

Campus Ministries Committee 30 minutes

TE Joyner opened the report in prayer.

Information- The new RUF work at SC State University was able to get \$20,000 in startup money this past month. We are still looking for the right man to lead this work. Please pray. A possible man has been located: Joel Brown.

Motion- That we transfer the oversight of Reformed Campus Fellowship at The Citadel to Shem Creek Presbyterian Church (ARP) and the Reverend Mark Brooks.

TE Joyner closed the report in prayer.

Shepherding & Church Vitality Committee:

TE Ron Steel opened the report in prayer.

M/S/C: to approve the call of TE Robert E. Hamby, III by the Lowcountry Presbytery MNA as a Church Planter. Terms of the call is attached.

M/S/C: to approve the call of TE Nathan Francis by the Lowcountry Presbytery MNA as a Church Planter. Terms of the call is attached.

TE John Schley was asked to come and speak to the presbytery regarding the matter of TE Howard Cole's resignation per BCO 23-1.

M/C: that Presbytery approve that the Pastoral Relationship between TE Howard Cole and Metro North Church be dissolved by mutual consent and that TE Cole be placed on the rolls as "without call" by Lowcountry Presbytery.

M/C:That T.E. Bill Schweitzer's July, 2019 newsletter updating his work in the U.K. be counted as providing his annual "laboring out of bounds" presbytery report.

The chairman, in behalf of the Session of Eastbridge, presented a short presentation about the Sanctity of Human Life Sunday – January 19, 2020 (3rd Sunday of January).

M/S/C: that today's offering of \$284 be designated for Church Planting efforts within the Lowcountry.

TE David Donovan closed the report of the Shepherding Committee with prayer.

General Assembly highlights:

- Roy Taylor will step down as PCA Stated Clerk at the adjournment of next year's GA in Birmingham, AL (June 16 19, 2020).
- GA next year will go back to beginning on Tuesday night.
- BCO Amendments approved at GA that will come before our Presbytery for vote
 - NOTE: Changing the BCO requires a majority vote of one GA, the majority vote of 2/3 of the Presbyteries, and a final majority vote of the subsequent Assembly (BCO 26-2).
 - Here are the two BCO amendments approved at GA that will come before our Presbytery for vote:

- From Overture 9, amend BCO 42-4, 43-2, and 43-3 regarding method and deadlines for filing (Rules Discipline: Appeals & Complaints)
- From Overture 17, amend BCO 32-8 to allow for video testimony (Rules of Discipline: General Provisions)
- Total number of PCA churches increased by 4 to 1,572.
- The number of mission churches increased by 11 to 355.
- Sunday School attendance increased by 679 to 94,349
- Total membership (communicant, non-communicant, ministers) increased by 10,057 to 384,793.
- Total reported giving increased by \$33,574,188 to \$870,679,800.
- The Assembly approved the request that churches contribute to the Administrative committee based on 0.35% of total tithes and offerings (excepting capital campaign projects).

RE David Walters, Jr. also gave a brief report on the General Assembly.

Dear Nathan

The Lowcountry Presbytery, being on sufficient grounds well satisfied with your ministerial qualifications, and having good hopes from our knowledge of your labors that your ministrations in the Gospel will be profitable to our spiritual interests, do earnestly call you, Reverend Nathan Francis to undertake the pastoral office of church planter to the Cane Bay Mission, with the MNA/Church Planting Committee serving as the temporary system of government (TSG), promising you, in the discharge of your duty, all proper support, encouragement and obedience in the Lord.
