The Thirteenth Stated Meeting of the Lowcountry was held at 9:00 a.m., January 26, 2019 at Metro North PCA in Goose Creek, SC.

Worship TE Howard Cole welcomed presbyters and then read a Call to Worship. After Service 9am singing and reading of Scripture, Mr. Nate Arnold preached a sermon from

Genesis 50:15-21. After properly fencing the table, TE John Schley and the elders

of Metro North PCA served the Lord's Table.

Call to Order The Thirteenth Stated Meeting of the Lowcountry Presbytery was called to order

by the moderator, TE Michel Walters at 10:20AM in the sanctuary Metro North

PCA in Goose Creek, SC.

The Moderator, TE Michel Walters, opened the meeting with prayer.

Quorum TE Michel Walters asked the Stated Clerk if there was a quorum.

The Stated Clerk declared that a quorum was present.

Docket M/S/C: that the modified docket for the 13th Stated meeting of Lowcountry presbytery submitted by the Administration Committee and posted on the Approval website and electronically distributed to presbyters be approved as presented.

Introduction of Guests & first-time commissioners were introduced.

Presentation The Moderator asked if there were any memorials. There were none.

of Memorials M/S/C: The Moderator appointed TE JP Sibley and TE John Mark Patrick to the

Prayer Time The presbyters broke into groups and spent time in a season of prayer for the 10:25am

churches and ministries within the Lowcountry Presbytery.

10:45pm TE Michael Walters called the presbyters back to order after the season of prayer **BUSINESS**

to conduct the business of the presbytery.

Judicial TE David Donovan opened the Judicial Committee report in prayer.

Committee: TE Donovan gave a brief background of the case that has come before the Judicial committee. See Judicial Report in the Appendix for details (Note: Mr. Robert Dale

Bates has asked that these records be public for the glory of God).

M/C: The committee moves that the Lowcountry Presbytery assume jurisdiction of this case of a former teaching elder previously censured by the old Palmetto Presbytery in order to make a ruling on his repentance and reaffirmation of faith.

The committee would ask that all guests and visitors be dismissed for this portion

M/C: the committee moves that the Lowcountry Presbytery enter into executive session for this portion of our report.

Mr. Robert Dale Bates came forward and gave his confession and a profession of his faith and hope in the gospel.

He then left the floor to allow presbytery to deliberate.

M/C: Mr. Moderator, the committee moves that the Lowcountry Presbytery accepts Mr. Bates' confession of sin and reaffirmation of faith, removes the censure of excommunication, and communicates his good standing to his congregation, Edisto Baptist Church.

TE David Donovan stated that given the action of this presbytery, the committee no longer believes it is necessary for our guests and visitors to remain outside and believe it would be appropriate to invite them back in for the remainder of our report.

M/C: the committee moves that we come out of executive session for the remainder of our report, and that we record the action of the Executive session in the regular minutes of presbytery.

Mr. Bates was then asked these questions from BCO 37-4:

- 1. Do you, from a deep sense of your great wickedness, freely confess your sins in thus rebelling against God, and in refusing to hear His Church; and do you acknowledge that you have been in justice and mercy cut off from the communion of the Church? **Mr. Bates answered Yes.**
- 2. Do you now voluntarily profess your sincere repentance and contrition for your sin and obstinacy; and do you humbly ask the forgiveness of God and His Church? **Mr. Bates answered Yes.**
- 3. Do you sincerely promise, through divine grace, to live in all humbleness of mind and circumspection; and to endeavor to adorn by a holy life the doctrine of God our Saviour? **Mr. Bates answered Yes.**

TE Donovan exhorted Mr. Bates and reminded him of the truth of the Gospel as he walks forward in new obedience in Christ.

The moderator, TE Michael Walters, made the following declaration of restoration:

Whereas, you <u>Robert Dale Bates</u>, have been shut out from the communion of the church, but now have manifested such repentance as satisfies the Church; in the name of the Lord Jesus Christ, and by His authority, we, the Lowcountry Presbytery Session of this church, do declare you absolved from the sentence of excommunication formerly pronounced against you, and we do restore you to the communion of the Church, that you may be a partaker of all the benefits of the Lord Jesus to your eternal salvation.

The presbyters gathered around and offered the right hand of fellowship to Mr. Bates and spent a season of prayer together in praise to our Restoring God. Prayer was offered to conclude this report.

M/S/C: to receive the report of the Judicial Committee as presented.

Examination for Licensure (Christian Experience, Bible Content, Theology, Church Government, written and preached sermon evaluation). **Mr. Nate Arnold** – (<u>Moderator</u>: See BCO 19-3 & 19-4). Mr. Nate Arnold was sustained in his Licensure exams (Christian Experience, Bible Content, Theology and Church Government) at the 12th Stated Meeting of the Lowcountry Presbytery. He preached before presbytery today.

M/S/C to accept Mr. Nate Arnold's written and preached sermon given today during our worship service as meeting the final requirement for Mr. Nate Arnold in his examination for licensure per BCO 19-2.

TE Michael Walters posed the questions of BCO 19-3 to Mr. Nate Arnold.

- 1. Do you believe the Scriptures of the Old and New Testaments, as originally given, to be the inerrant Word of God, the only infallible rule of faith and practice?
- 2. Do you sincerely receive and adopt the Confession of Faith and the Catechisms of this Church as containing the system of doctrine taught in the Holy Scripture?
- 3. Do you promise to strive for the purity, peace, unity and edification of the Church?
- 4. Do you promise to submit yourself, in the Lord, to the government of this Presbytery, or of any other into the bounds of which you may be called?

Mr. Nate Arnold answered the questions in the affirmative.

The moderator offered prayer and give Mr. Nate Arnold the charge of BCO 19-4. In the name of the Lord Jesus Christ, and by that authority which He has given to the Church for its edification, we do license you to preach the Gospel in this Presbytery wherever God in His providence may call you; and for this purpose may the blessing of God rest upon you, and the Spirit of Christ fill your heart. Amen.

M/S/C: At Metro North Church, Goose Creek, SC, the 26th day of January, 2019 the Lowcountry Presbytery, having received testimonials commending Mr. Nate Arnold, proceeded to submit him to the prescribed examination for licensure, which was met to the approval of the Lowcountry Presbytery. Having satisfactorily answered the questions for licensure, Mr. Nate Arnold was licensed by the Lowcountry Presbytery to preach the Gospel within the bounds of this Presbytery.

- Spent initial months trying to figure out who we were and how to function as part of the Lowcountry Presbytery

- Mission Statement: To equip, connect, and encourage women for ministry in the Lowcountry Presbytery.
- Druid Joyner from Grace Coastal hosted a retreat for senior pastor's wives from our presbytery in March of 2017. It was an incredible time of relaxing and getting to know each other that we hope to repeat.
- We hosted an event in January 2018 for pastor/elder/deacon wives or
 "leadership marriages," that included a panel of experienced women in
 those positions. We did a survey following the event and got great feedback
 from the women who attended about the helpfulness of the panel and the

- We have an event planned for all women of the Presbytery on March 30th.
 Wendy Alsup, a published author and speaker from New City Fellowship, will be doing a teaching time, and we will break into small groups to further discuss the teaching.

My Service as Regional Advisor for the Mid-Atlantic Region for the Women's Ministry of the PCA I am now serving as the Regional Advisor for the following presbyteries located in the Mid-Atlantic Region: Blue Ridge, Calvary, Catawba Valley, Central Carolina, Eastern Carolina, Fellowship, James River, Lowcountry, New River, Palmetto, Pee Dee, Piedmont Triad, Tidewater, Western Carolina, and Westminster.

My job is to connect women in the Mid-Atlantic Region with the resources and trainers of the PCA women's ministry and to connect the women with each other. INTRODUCTION

Mr. Moderator, back on September 24, 2018, I received an email from Chris Bennett alerting me to a matter for our Judicial Committee. The matter concerned a discipline case originally handled by the old Palmetto Presbytery. Given that this case involved a minister at Grace Coastal Church in Okatie, which is now a member of the Lowcountry Presbytery, it has fallen to our committee to determine if there is action for our presbytery to take in this matter. Having researched the case, interviewed the parties involved, and reviewed the Book of Church Order, our committee believes that there is action for our presbytery to take, although it is out of the ordinary. The Judicial Committee believes that the Lowcountry Presbytery must first assume jurisdiction of this case in order to adjudicate it.

Jurisdiction of the Case

This case would be an unusual case for us to adjudicate in that the penitent is not seeking to be restored to office (*BCO* 34-8, 37-5), but only desires the removal of the censure of

excommunication. *BCO* 37-9.b instructs us that penitents, "may only be restored to the communion of the church through a session." It also goes on to say that, "Once the penitent is restored, and therefore a member of a local church, the authority to remove any other censure(s) in respect to office, concurrently imposed with that of excommunication shall belong to the court originally imposing such censure(s)." According to the *BCO*, then, the presbytery would not normally do the work of removing the censure of excommunication. That process would normally be handled by a local session.

The problem for the penitent is that he does not currently live in proximity to a PCA congregation, and hence, is unable to pursue membership in one of our local congregations. The case is further complicated by the fact that he has already pursued membership in a Southern Baptist congregation where he lives.

Given that this man's local congregation is outside the courts of our denomination and one with whom we do not have fraternal relations, and given that he cannot pursue membership in a local PCA congregation due to distance, it is the recommendation of the Judicial Committee that the Lowcountry Presbytery is the appropriate court to adjudicate this case as per *BCO* 13-9, which allows a presbytery to assume original jurisdiction of a case when a session cannot exercise its authority.

So, Mr. Moderator,

The committee moves that the Lowcountry Presbytery assume jurisdiction of this case of a former teaching elder previously censured by the old Palmetto Presbytery in order to make a ruling on his repentance and reaffirmation of faith.

[If motion passes, ask for guests to leave or move to enter into executive session, if needed.]

Mr. Moderator, the committee would ask that all guests and visitors be dismissed for this portion of our report and that Mr. John Ring of Grace Coastal Church be allowed to participate.

Mr. Moderator, the committee moves that we enter into executive session for this portion of our report and that Mr. John Ring of Grace Coastal church be allowed to participate.

Facts and Timeline of the Case

The case before us involves former TE Robert Dale Bates, Jr. While serving as the Pastor of Grace Coastal Church in Okatie, former Mr. Bates entered into an inappropriate relationship with a woman who was not his wife early in the spring of 2011, which then progressed into adultery. Mr. Bates covered up the adultery from his wife and from the session of Grace Coastal Church.

Mr. Bates resigned his position as Pastor at the beginning of October 2011, under the guise of marriage and family trouble, without ever revealing the adulterous relationship. However, shortly after resigning, the former Mrs. Bates discovered emails revealing the adulterous relationship and

went to the session of Grace Coastal Church for help. Mr. Bates was unresponsive to the session, so the session alerted the former Palmetto Presbytery.

The former Palmetto Presbytery reached out to Mr. Bates through both the Shepherding Committee and the Judicial Committee concerning the allegations of adultery. Through correspondence Mr. Bates provided a signed statement of confession and a signed request that his case be dealt with without process. He acknowledged his adulterous relationship, but he refused to repent or to meet with anyone from Presbytery to discuss discipline.

On January 26, 2012 at the One Hundred Thirteenth Stated Meeting of the former Palmetto Presbytery, it was determined that Mr. Bates be deposed from office in accordance with *BCO* 34-7 and that if he continue to be uncooperative that he be excommunicated per *BCO* 36-7. It was also determined that the deposition would not become effective until the question of Mr. Bates' church membership was resolved or his excommunication took place.

Mr. Bates continued in his contumacy, which led the presbytery to impose the censure of suspension from the sacraments on April 26, 2012 at its One Hundred Fourteenth Stated Meeting and determined to revisit the case at its next meeting to consider the censure of excommunication.

Presbytery continued to reach out to Mr. Bates, including asking his permission to assign him to a local church. Mr. Bates persisted in his contumacy indicating that he was unwilling to do anything further with or hear from the Presbytery. So, the Presbytery officially deposed Mr. Bates, from the office of elder and excommunicated him from the Church on July 26, 2012 at its One Hundred Fifteenth Stated Meeting.

It is the privilege and joy of this committee to report that it is our opinion that the discipline of the old Palmetto Presbytery has had its desired intention of reclaiming a disobedient sinner. Mr. Bates now recognizes in addition to his previous confession of adultery, that his stubborn refusal to repent of it, his dishonesty with his wife and session about it, and his stubborn refusal to obey and comply with the former Palmetto Presbytery was sinful, and that the presbytery was correct in its concerns and actions.

His desire today is to do what he did not do originally, be accountable for his sins and seek forgiveness, to reaffirm his faith in Jesus Christ alone for his salvation, and to be restored to communion in Christ's Church. In addition to accepting responsibility for the sin surrounding his adulterous relationship and his contumacy, he would also like to come as his own accuser concerning additional sins he committed during his period of contumacy.

Mr. Bates is here today due in large part to the diligent efforts of Mr. John Ring of Grace Coastal Church. He is here as one who is married to the woman with whom he committed adultery. He is here as one who has taken steps to be reconciled to his children and former wife. With the support of his current wife, former wife, and children, Mr. Bates has already gone to the session of Grace Coastal Church to confess his sins. In response to what they heard, the session then invited Mr. Bates to confess his sins to the congregation of Grace Coastal Church, which went well.

Mr. Bates has met with the committee multiple times and has done the things we have asked of him. It is our opinion that he out of a true sense of his sin, and apprehension of the mercy of God in

Christ, is with grief and hatred, turning from it unto God, with full purpose of, and endeavoring after, new obedience. And that is why we have asked you to hear him.

Are there any questions before we invite Mr. Bates forward?

Hearing and Adjudicating the Case

Invite Mr. Bates forward to give his confession and profession of faith. Then have him leave for deliberation.

Deliberate/Answer Questions

Motion:

Mr. Moderator, the committee moves that the Lowcountry Presbytery accepts Mr. Bates' confession of sin and reaffirmation of faith, removes the censure of excommunication, and communicates his good standing to his congregation, Edisto Baptist Church.

[If motion passes, ask that visitors and guests be allowed to return, or move that we come out of executive session if we are in one]

Mr. Moderator, given the action of this presbytery, the committee no longer believes it is necessary for our guests and visitors to remain outside and believe it would be appropriate to invite them back in for the remainder of our report.

Mr. Moderator, the committee moves that we come out of executive session for the remainder of our report, and that we record the action of the Executive session in the regular minutes of presbytery.

RESTORATION TO COMMUNION WITH THE CHURCH

1. Do you, from a deep sense of your great wickedness, freely confess your sins in thus rebelling against God, and in refusing to hear His Church; and do you acknowledge that you have been in justice and mercy cut off from the communion of the Church?

Answer, I do.

2. Do you now voluntarily profess your sincere repentance and contrition for your sin and obstinacy; and do you humbly ask the forgiveness of God and His Church?

Answer, I do.

3. Do you sincerely promise, through divine grace, to live in all humbleness of mind and circumspection; and to endeavor to adorn by a holy life the doctrine of God our Saviour?

Answer, I do.

Exhortation of Encouragement and Comfort

Sentence of Restoration in the following words:

Whereas, you Robert Dale Bates, Jr., have been shut out from the communion of the church, but now have manifested such repentance as satisfies the Church; in the name of the Lord Jesus Christ, and by His authority, we, the Lowcountry Presbytery, do declare you absolved from the sentence of excommunication formerly pronounced against you, and we do restore you to the communion of the Church, that you may be a partaker of all the benefits of the Lord Jesus to your eternal salvation.

APPLICABLE PORTIONS OF THE BOOK OF CHURCH ORDER (BCO)

- 13-9. The Presbytery has power to receive and issue* appeals, complaints, and references brought before it in an orderly manner. In cases in which the Session cannot exercise its authority, it shall have power to assume original jurisdiction.
- 30-4. Excommunication is the excision of an offender from the communion of the Church. This censure is to be inflicted only on account of gross crime or heresy and when the offender shows himself incorrigible and contumacious. The design of this censure is to operate on the offender as a means of reclaiming him, to deliver the church from the scandal of his offense, and to inspire all with fear by the example of his discipline.
- 34-4. a. When a minister accused of an offense is found contumacious (cf. 32-6), he shall be immediately suspended from the sacraments and his office for his contumacy. Record shall be made of the fact and of the charges under which he was arraigned, and the censure shall be made public. The censure shall in no case be removed until the offender has not only repented of his contumacy, but has also given satisfaction in relation to the charges against him.

b. If after further endeavor by the court to bring the accused to a sense of his guilt, he persists in his contumacy, he shall be deposed and excommunicated from the Church.

32-6. a. When an accused person shall refuse to obey a citation, he shall be cited a second time. This second citation shall be accompanied with a notice that if he does not appear at the time appointed (unless providentially hindered, which fact he must make known to the court) he shall be dealt with for his contumacy (cf.

BCO 33-2; 34-4).

b. When an accused person shall appear and refuse to plead, or otherwise refuse to cooperate with lawful proceedings, he shall be dealt with for his contumacy (cf. BCO 33-2; 34-4).

33-2. When an accused person is found contumacious (cf. 32-6), he shall be immediately suspended from the sacraments (and if an officer from his office) for his contumacy. Record shall be made of the fact and of the charges under which he was

arraigned, and the censure may be made public, should this be deemed expedient by the Session. The censure shall in no case be removed until the offender has not only repented of his contumacy, but has also given satisfaction in relation to the charges against him.

33-3. If after further endeavor by the court to bring the accused to a sense of his guilt, he persists in his contumacy, he shall be excommunicated from the Church.

34-8. A minister under indefinite suspension from his office or deposed for scandalous conduct shall not be restored, even on the deepest sorrow for his sin, until he shall exhibit for a considerable time such an eminently exemplary, humble and edifying life and testimony as shall heal the wound made by his scandal. A deposed minister shall in no case be restored until it shall appear that the general sentiment of the Church is strongly in his favor, and demands his restoration; and then only by the court inflicting the censure, or with that court's consent. The removal of deposition requires a three-fourths (3/4) vote of the court inflicting the censure, or a three-fourths (3/4) vote of the court to which the majority of the original court delegates that authority.

36-6. Excommunication is to be administered according to one or other of the two modes laid down for indefinite suspension, or to be inflicted in public as the court may decide. In administering this censure the moderator of the Session shall make a statement of the several steps which have been taken with respect to the offending brother, and of the decision to cut him off from the communion of the church. He shall then show from Matthew 18:15-18 and 1 Corinthians 5:1-5 the authority of the church to cast out unworthy members, and shall explain the nature, use and consequences of this censure.

When an excommunicated person shall be so affected with his state as to be brought to repentance, and to desire to be readmitted to the communion of the church, the Session, having obtained sufficient evidence of his sincere penitence, shall proceed to restore him. This may be done in the presence of the court, or of the congregation as seems best to the Session. On the day appointed for his restoration, the minister shall call upon the

excommunicated person and propose to him in the presence of the court or the congregation the following questions:

1. Do you, from a deep sense of your great wickedness, freely confess your sins in thus rebelling against God, and in refusing to hear His Church; and do you acknowledge that you have been in justice and mercy cut off from the communion of the Church?

Answer, I do.

- 2. Do you now voluntarily profess your sincere repentance and contrition for your sin and obstinacy; and do you humbly ask the forgiveness of God and His Church? Answer, I do.
- 3. Do you sincerely promise, through divine grace, to live in all humbleness of mind and circumspection; and to endeavor to adorn by a holy life the doctrine of God our Saviour?

Answer, I do.

Here the minister shall give the penitent a suitable exhortation, encouraging and comforting him. Then he shall pronounce the sentence of restoration in the following words:

Whereas, you _______, have been shut out from the communion of the church, but now have manifested such repentance as satisfies the Church; in the name of the Lord Jesus Christ, and by His authority, we, the Session of this church, do declare you absolved from the sentence of excommunication formerly pronounced against you, and we do restore you to the communion of the Church, that you may be a partaker of all the benefits of the Lord Jesus to your eternal salvation.

The whole shall be concluded with prayer and thanksgiving.

- 37-9. In the case of the removal of censures from, or the restoration of, a minister, jurisdiction shall be as follows:
 - a. If the censure(s) does not include excommunication, the presbytery inflicting the censure(s) shall retain the authority to remove the censure(s) and, at its discretion, restore him to office. This authority is retained by the presbytery even when a divested or deposed minister is assigned, under the provisions of BCO

46-8, to a session.

b. If the censure includes excommunication, the penitent may only be restored to the communion of the church through a session (BCO 1- 3; 6-4; 57-4; 57-5; 57-6). Once the penitent is restored, and therefore a member of a local church, the authority to remove any other censure(s) in respect to office, concurrently imposed with that of excommunication shall belong to the court originally imposing such censure(s).
