Bio of Rev. John Song:

My personal journey to faith and service into ministry is one that many would seem "routine", but one that nevertheless demonstrates God's faithfulness through covenantal families. I grew up as Pastor's Kid in a Korean-American home, where my parents would teach me the principles of the faith, and telling me the stories of Scriptures as I fell asleep. I remember fondly my mother's dramatic telling of the story of Jonathan and David again and again every night; perhaps it was my favorite story because of the service and sacrifice that Jonathan made for David's life; a characteristic that was a family trait of my parents. Both my father and mother came to America with less than \$1,000 in their pockets with the goal of serving the people for the sake of the gospel, and over the course of the next 29 years raised two children while planting a church in Columbia, MD. The ability to grow up with people who loved the Lord shaped my early childhood in this context, but it wasn't until I reached a middle school age where the Holy Spirit convicted me of my sin and Christ called me into belief and repentance that he had died and rose again, conquering Satan, sin, and death and proclaiming himself victorious over all. This was largely due to the preaching ministry of my middle school pastor, who lead me to faith, discipled me, and exhorted me to live as a new creation (2 Corinthians 5:17) for the glory of the Gospel. Now as a young Christian, I was met with many temptations and trials as a young teen, and it was during this time that the church experienced growing pains during my high school and early college years. I found myself without a direction and mentorship in my faith as I continued in a pattern of sin, shame, repentance, and trying to pull myself up by my own bootstraps, but found myself failing each and every single time. I realized now that it was because my understanding of the Gospel was tainted by a legalistic and man-centered perseverance, and that like Paul, I would do the very things that I hated to do (Romans 7:18).

It wasn't until several men entered into my life that encouraged me to continue a deeper calling and service into the ministry at my church, and a deepened understanding of the Gospel. Both the young adult pastor and the youth director of the church where I was serving took me under their wings, and helped me to grow through the service of the church and also personal one-on-one mentorship. It was here where more clarity was given to the Gospel of grace and the perseverance of the saints that I had been taught in my middle school years but never reinforced in my later years. Both of these men were patient and gracious through my immaturities and growing pains of that period, and gave me a pastoral heart for the care and concern that my parents would always read to me about. In that service I realized my love in the service and work of the church, and began exploring a calling into pastoral ministry after three years as a music teacher in the Howard County Public School System. When the youth director resigned from his post in 2011, the call for me to take up the role of pursuing ministry began, and I knew that I needed theological training to pursue my calling into Scriptures further. Having been influenced and convinced by the growth in Reformed theology during this time, I pursued Reformed Theological seminary in Washington D.C. where the covenantal understanding of Scriptures leaped out of the page for me, of a kingdom that is already here but not-yet arrived. There I found my foundation for grasping the truth of Scripture, and I knew there was no turning back.

Now as I seek ordination and service in the church, I wish for the Lord to continue the work that he has already started within me (Philippians 1:6), as he shapes me to be a minister of the Word, and I look forward to the challenges and growth ahead. I am excited to serve and to sacrifice my life for the sake of the Gospel-- much like the bible stories I grew up hearing-- and looking forward to how the Lord will use me on this journey ahead.

Stated Exceptions to the Confession:

Pertaining to the Sabbath:

WCF 21.8 "...recreations; but also are taken up, the whole time, in the public and private exercises of His worship"

WLC Q 117: "worldly employments and recreations..."

WSC Q 60 "sanctified by a holy resting... spending the whole time in the public and private exercises of God's worship"

In the Confession's understanding of the Sabbath, while I agree with the significance of the Sabbath day and Sabbath worship, there are several exhortations that are unclear in their application and binding in ways that cannot find their direct or indirect inference from Scripture. The first is the statement that the whole time is to be spent in public and private exercises of God's worship. How public and private worship all day on the Sabbath is to be done is a statement that scripture in either testament neither gives any direct command. It is indeed sad that our understanding of the Sabbath in our modern times has been minimized and marginalized by Christians in our age to excuse itself into neglect of public worship, but I don't believe the Confession can be used in a way that binds the entire time of the day to worship in a way that is not feasible in a variety of scenarios. Nor can we say that "worship" can simply be any activity we claim it to be, as to over spiritualize the actions of everyday activities. The second issue I have is the idea that holy rest is sanctified (perhaps overstated as "only sanctified") through holy worship. In stating this phrase in

WSC Q60, the Confession overemphasizes the division of spiritual/physical that understates the role and necessity of physical rest and even restful recreation as a part of rest. If our understanding of the physical body is not Platonic, then it must follow that as a new creation our physical rest (and its reasonable recreation and fellowship) would also be allowable in the idea of a holy rest(1 Corinthians 6:19-20).

Concerning Rev. Song's difference concerning the Sabbath, the committee recommends his view be considered merely semantic.

M/C: that Rev. John Song's stated differences with our Standards concerning the Sabbath be considered merely semantic.

Pertaining to the Role of Civil Government:

WCF 23.3. "Yet, <u>as nursing fathers, it is the duty of civil magistrates to protect the</u> <u>church of our common Lord</u>, without giving the preference to any denomination of Christians above the rest, in such a manner that <u>all ecclesiastical persons whatever shall</u> <u>enjoy the full, free, and unquestioned liberty of discharging every part of their sacred</u> <u>functions, without violence or danger</u>"

In the American revision of the Confession, the role of church and state I believe is properly defined in scriptural terms, save this line that was preserved by the Philadelphia Assembly (In its original draft, with no scriptural proofs). I don't believe this can be defended from scripture, and the use of an addendum proof text of Isaiah 49:23 "nursing fathers" (added by the OPC later and adopted by the PCA) is an over prescriptive reading when viewed in context of a theocratic national Israel. Rather, if we are indeed sojourners and exiles in a foreign land(1 Peter 2:11), then our posture should be one of understanding the rightful role of how the state and the church are to relate to each other, as one not in expectation of favorable, preferential, or necessary treatment, but rather one that is willing to accept both praise and persecution, with the understanding of the not yet Kingdom that will be consummated. In other words, to quote Chad Van Dixhoorn in his "Confessing the Faith", In the New Testament the assembly or church of God is Israel, but there is no chosen political nation (eg. Gal 6:16, Eph 2:11-16) (pg.314). This means that the state, while certainly will be favorable for them to protect the churches, it should not then follow that Christians and the church should *expect biblically* such protection in this life.

Concerning Rev. Song's difference concerning the role of civil authorities to protect the church, the committee recommended his view be considered merely semantic.

M/C: that Rev. John Song's stated differences with our Standards concerning the role of civil authorities to protect the church be considered merely semantic.

TE Mark led the examination of TE Song in the area of his views touching Theology.

M/C that the examinations of TE Song on his views touching Theology be arrested.

TE Mark led the examination of TE Song in the area of his views touching Sacraments.

M/C that the examination of TE Song on his views touching Sacraments be arrested.

TE Mark led the examination of TE Song in the area of his views touching Church Government.

M/C that the examination of TE Song on his views touching Church Government be arrested.

TE Mark asked TE Song if there had been any changes to any of his ordination vows of BCO 21-5. TE Song indicated that there were no changes.

TE Song was excused from the floor of Presbytery.

M/S/C that the examination of TE Song in Christian Experience be sustained.

M/S/C that the examination of TE Song in Views in Theology be sustained.

M/S/C that the examination of TE Song in Views in Sacraments be sustained.

M/S/C that the examination of TE Song in Views of Church Government be sustained.

M/S/C that examinations for transfer of ordination for TE Song in its entirety be approved and that he be entered on the rolls of Lowcountry Presbytery.

M/S/C that TE Song be received into membership in the Lowcountry Presbytery, being received from Chesapeake Presbytery who has released him pending his acceptance into Lowcountry Presbytery.

TE Mark welcomed TE Song as a Teaching Elder of the Lowcountry Presbytery and extended the right hand of fellowship to him, after which he was asked to sign the ministerial obligation form per BCO 13-7.

Rev. Song was asked if he would accept the call presented to him from Redeemer Presbyterian. He indicated that he would accept it.

Motion: The Shepherding Committee has reviewed and approved TE Song's Call Package as being sufficient to provide for his needs. That the following Commission be appointed to install TE John Song as Assistant Pastor at Redeemer Presbyterian Church on a date to be announced with TE Craig Bailey as convener, assisted by at least 2 TE and 2 Ruling Elders. TE Bailey, convener, TE Jon Payne.

TE Mark led the presbytery in prayer for TE Song and his future ministry at Redeemer Presbyterian Church and closed the report in prayer.

The Committee was asked to address the issue of providing basic theological questions to candidates by providing their answers to the presbytery as a whole. They are asked to report back at the next presbytery.
